## Christmas Breakfast Bacon Casserole

### INGREDIENTS:

- 7 slices white bread (crusts removed & cubed)
- 2 cups cheddar cheese, shredded
- 6 eggs
- 3 cups whole milk, no substitutes
- 1 teaspoon ground mustard
- ½ teaspoon salt
- ¼ teaspoon pepper
- 6 slices bacon, cooked & crumbled

### DIRECTIONS:

1. In greased 11 x7 x2 baking dish, combine the bread cubes & cheese
2. In large bowl, whisk the eggs, milk, mustard, salt, & pepper; pour over bread & cheese.
3. Top with bacon.
4. Cover & refrigerate overnight.
5. Remove from the refrigerator 30 minutes before baking.
6. Bake, uncovered, at 350 degrees F for 50 55 minutes or until knife inserted near the center comes out clean.

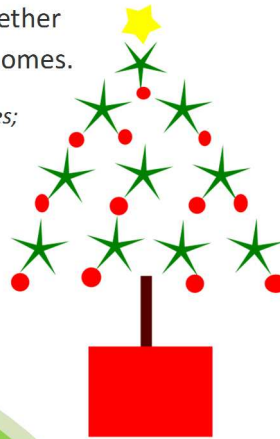
## Remember What's Really Important
